

Promo Rules

High Rollers of St. Lucie, Inc., also known as the Sponsor, operates www.TaoSweeps.com, a social casino gaming site ("TaoSweeps.com") whereby users may purchase Gold Coins to play the games for entertainment purposes only. Gold Coins are also available for free via various promotional offerings. We provide users who engage in certain qualifying promotional activities, including a free alternate method of entry, with the opportunity to obtain Sweep Coins that may be used to play the games for a chance to win Prizes. By accessing the Platform, you agree to these Promo Rules and our Terms and Conditions at www.TaoSweeps.com/termsandconditions, incorporated by reference herein. The terms used in these Promo Rules have the same meaning as assigned to those terms in the Terms and Conditions. The Sweepstakes are subject to all applicable national, federal, state, and local laws and regulations. Redeeming a Prize is contingent upon fulfilling the requirements set forth in this Agreement.

NO PURCHASE OR PAYMENT IS NECESSARY TO PARTICIPATE IN THIS SWEEPSTAKES OR TO WIN PRIZES. TAOSWEEPS.COM DOES NOT OFFER ANY REAL MONEY GAMING. YOU UNDERSTAND AND AGREE THAT SWEEP COINS CANNOT BE PURCHASED AND HAVE NO REAL WORLD OR CASH VALUE. VOID WHERE PROHIBITED OR RESTRICTED.

1. Eligibility

The Sweepstakes are open to (i) natural persons, (ii) who are at least eighteen (18) years old or the minimum age in their jurisdiction at the time of entry, whichever is greater, and (iii) the owner of an account on TaoSweeps.com and an accompanying email address. The Sweepstakes are not open to any person (i) living in a jurisdiction where TaoSweeps.com's social casino services or the Sweepstakes are illegal, (ii) living outside of the United States. (iii) living or playing in the U.S. States of California, Connecticut, Idaho, Louisiana, Michigan, Mississippi, Montana, Nevada, New Jersey, New York, Tennessee, Washington, or the Canadian. (iv) on the Treasury Department's list of Specially Designated Nationals, or (v) that is, or is an immediate family member of, an employee, distributor, associate, concessionary, or other agent of TaoSweeps.com. To participate in The Sweepstakes, you must create an account and satisfactorily complete the verification process.

2. Promotional Period

The Sweepstakes run concurrently with the business of promoting our social casino games and our brand to our users. Our servers are the official timekeeping device of The Sweepstakes. The Sweepstakes will run until December 31, 2026. TaoSweeps.com reserves the right to cancel, pause, modify, or suspend any part of or all of The Sweepstakes with immediate effect owing to events or circumstances outside of its reasonable control. Any event or circumstance impairing the proper functioning or integrity of The Sweepstakes will be determined by TaoSweeps.com, and corrective action will be taken by TaoSweeps.com in its sole discretion.

3. Sweep Coins

You may receive Sweep Coins in a number of ways, including:

- As a promotional bonus when purchasing some packages of Gold Coins.
- By entering no-cost giveaways on the LuckRush.io social media pages.
- By logging into your account for the first time each day and following the instructions on the pop-up screen to claim a daily login bonus.
- By spinning the Lucky Wheel on the Website once every twelve hours.
- By logging into your account on certain holidays and claiming bonus Sweep Coins.
- As a sign-up bonus upon account creation.
- As a bonus on your birthday if you have completed the KYC verification prior to the date of your birthday.
- As a bonus when you reach a new VIP level through gameplay.
- By completing challenges through gameplay.
- By clicking on a link in an email sent by TaoSweeps.com to the email address associated with the player's account.
- As a bonus for leaving a review of TaoSweeps.com on any public review platform, as confirmed by sending a link to the review of TaoSweeps.com to chat support and limited to only one bonus per platform. Each review must be unique, though you may and should be honest in your review. Reviews do not need to be positive to receive this bonus. Note, you are responsible for reading, agreeing to, and adhering to FTC guidelines on reviews in exchange for benefits in order to obtain this bonus. Many such guidelines can be found [here](#).
- By participating in occasional promotions, such as pop-up gift boxes on TaoSweeps.com.
- By referring a new player when the new player signs up for an account on TaoSweeps.com and uses the existing player's referral code at the time of sign up.
- By participating in weekly tournaments based on the prior week's Gold Coin gameplay.
- Other free promotion codes as we may offer from time to time by a message prominently displayed on TaoSweeps.com or via email.
- Alternative method of entry ("AMOE") by submitting a written request for free Sweep Coins (as described below).

The amount of Sweep Coins received for each qualifying activity is prominently displayed on TaoSweeps.com. We reserve the right to change these amounts in our sole and absolute discretion, and to change the balance of Sweep Coins on your account at any time and for any reason, in our sole discretion, including removing Sweep Coins associated with inactive accounts. Sweep Coins may be of limited duration. Sweep Coins cannot be purchased on TaoSweeps.com.

You may receive two (2) Sweep Coins by obtaining a Voucher Request Code and sending a standard post card or piece of white paper ("Request Card") which must be size A4 (8.27 x 11.69 inches), unfolded, otherwise blank and unlined and placed inside a stamped envelope addressed in handwriting,

to the following address and satisfying the requirements set out below. Participants must:

1. Address the envelope to 701 NW 5th Ave, Suite 1101, Fort Lauderdale, Florida 33311.
2. Handwrite your return address on the front of the envelope and the words: "Sweepstakes Entries" and
3. Handwrite all of the following on only one side of the Request Card inserted inside the envelope:
 - a. In the top-left corner, one unique Voucher Request Code (see more below);
 - b. Under the Voucher Request Code, in the following order:
 - i. Your full name as shown on your government issued identification;
 - ii. The email address registered to your account;
 - iii. The return/residential address registered to your account; and
 - iv. The following statement:
"I wish to receive Sweep Coins to participate in the sweepstakes promotions offered by TaoSweeps.com. By submitting this request, I hereby declare that I have read, understood and agree to be bound by TaoSweeps.com's Terms and Conditions and Promo Rules."
 - c. FOR THE AVOIDANCE OF DOUBT, COMBINED REQUESTS SENT VIA PACKAGE OR PARCEL DO NOT MEET THE REQUIREMENTS SET OUT ABOVE AND ARE INVALID.

There is a limit of one Request Card per outer envelope. For each Request Card you submit in accordance with the above requirements, you will receive two (2) Sweep Coins. The Sweep Coins will be added to your account once we have verified all requirements have been met. NOTE: You must ensure that their handwriting is legible. If your handwriting is not legible, the entry will be void, and the Sweep Coins will not be added to your account. We will determine the legibility of your handwriting in our sole discretion. THE REQUEST MUST ONLY BE MADE BY YOU AND MUST BE POSTED FROM THE SAME STATE OR PROVINCE AS YOUR VERIFIED RESIDENTIAL ADDRESS. Requests made by any other individual or any entity (including but not limited to commercial sweepstakes subscription notification and/or entering services) or posted from a state or province different to your verified residential address will be declared invalid, and Sweep Coins will not be added to your account. Tampering with the entry process or the operation of the sweepstakes, including but not limited to the use of any device or software to automate the Sweep Coins request/entry process or to unfairly assist you with meeting the handwriting requirement, is prohibited and any requests/entries deemed by us, in our sole discretion, to have been submitted in this manner will be void. Where there is an issue or fault with an envelope used by you to request free Sweep Coins, such that it does, or is reasonably likely to, cause damage to, or otherwise adversely affect, equipment used or procedures implemented to process mailed in requests (for example, handmade envelopes that are not suitable for machine processing due to poor

quality or non-standard adhesive or paper), such entry will be void. In the event a dispute regarding the identity of the individual who actually submitted a request or whether a request satisfies the requirements set out above cannot be resolved to our satisfaction, the affected request/entry will be deemed ineligible.

A Voucher Request Code is a unique combination of 12 digits that you can obtain by going to the Promotion Tab, then choosing Request A Voucher Code. A Voucher Request Code is unique, can only be used once, and expires thirty (14) days after it is displayed. The purpose of a Voucher Request Code is to assist with the efficient and effective processing of a Participant's Request Card. Request Cards containing an expired Voucher Request Code at the time of processing will be void. A Voucher Request Code can only be used by you in connection with your own account used to generate the code. If you are suspected by us to have directly or indirectly provided a Voucher Request Code to another person, then you may be disqualified and lose your eligibility to participate in the sweepstakes, at our sole discretion.

4. Games

Sweep Coins can be used to play Sweep Token Games, which give you a chance to compete in various competitions to win more Sweep Coins. Sweep Coins that have not been played in at least one game are "Unplayed Sweep Coins." Unplayed Sweep Coins cannot be redeemed for Prizes. Sweep Coins won in Sweep Token Games ("Redeemable Sweep Coins") are redeemable for Prizes or may be used to play Sweep Token Games. We reserve the right to change the exchange rate between Redeemable Sweep Coins and Prizes at any time and for any reason, in our sole discretion, without notice to you. The amount of Sweep Coins required to play each game varies and is prominently displayed on TaoSweeps.com.

The amount of Sweep Coins required to play each game will be detailed next to the game. You may be able to increase the amount of Sweep Coins you play the game with, so you can increase your potential winning eligibility.

Gold Coins can never be used to enter Sweep Token Games.

5. Odds

The odds of winning vary on the specific games played, and the amounts wagered on such games. You may obtain the specific odds of winning any particular gameplay by submitting a written request to TaoSweeps.com before participating in the activity. TaoSweeps.com reserves the right to adjust the odds of winning the Sweepstakes at any time.

6. Prizes

To redeem Prizes, you may withdraw any net awards of Redeemable Sweep Coins in any given day to the payment method that you direct, provided that you have completed the verification process and you own the account to which the funds are deposited. Prizes will be redeemed for United States Dollars (USD) for players located within the United States, and for Canadian Dollars (CAD) for players located within Canada. TaoSweeps.com's decision on how to administer, manage the operation of the games, and award Prizes is final and binding. Violation of our Terms and Conditions makes any Prize null and void. Prizes are not awarded until redeemed. You have no right to Sweep Coins that have not been

redeemed.

We will only process a Prize redemption if the redeemed value of the Prize is at least \$50 when redeemed to gift cards or at least \$100 when redeemed to cash ("Minimum Payment Threshold"). Consequently, your account must have a balance of at least 50 Sweep Coins before requesting a prize redemption.

Maximum Redemption Request and Loyalty Program:

The maximum redemption request is based on the user's frequency of gameplay and participation in the TaoSweeps.com promotions, as captured in the user's progress in the Loyalty Program (measured in "EXP Points"). EXP Points are earned by engaging in the Company's activities, promotions, purchases, events, and gameplay. Levels (also "VIP Levels") cannot be transferred to another player, and EXP Points cannot be exchanged for anything of value. Players are automatically enrolled upon completion of the KYC process. Players can see their status and EXP Points bar on the Website on the "Lobby" page.

- Players who complete the KYC process may redeem a maximum of \$500 per 24 hours.
- Players who have 5,000 EXP Points may redeem a maximum of \$1,000 per 24 hours.
- Players who have 20,000 EXP Points may redeem a maximum of \$1,500 per 24 hours.
- Players who have 100,000 EXP Points may redeem a maximum of \$2,500 per 24 hours.
- Players who have 250,000 EXP Points may redeem a maximum of \$4,000 per 24 hours.

In Florida, the maximum redemption value of a Sweep Coins Prize won on any one spin or play, via your participation in the sweepstakes, is \$5,000. Any prize valued in excess of \$5,000 will be reduced to a maximum of value of \$5,000.

We reserve the right to, in our sole discretion, limit your redemption of Sweep Coins to \$10,000 per day or any other amount over any time that we consider necessary to satisfy our regulatory obligations or the requirements of our partners and/or suppliers. No more than the stated number of Prizes will be awarded.

Sweep Coins are not transferable, and no substitution will be made except as provided herein at our sole discretion. We reserve the right to substitute the listed Prize of equal or greater value for any reason owing to circumstances outside our reasonable control.

For Canadian Players to redeem Prizes, they must correctly answer within the time period defined by us, without mechanical or other aid, a skill-testing question, which is to be administered through your account or via email.

7. Taxes and Fees

TaoSweeps.com is not responsible for any taxes, bank charges, and transaction fees associated with any Prizes. You are solely responsible for any incurring taxes, bank charges, or transaction fees associated with the Prizes.

8. Verification

You will hold TaoSweeps.com and our employees, clients, subsidiaries, affiliated companies, agents, media partners, officers, directors, content providers, and related parties not accountable for, and you will indemnify same from, any and all costs, expenses, liabilities and damages that may arise as a result of (i) your acceptance of any Prize, (ii) your use or inability to use any and all materials on TaoSweeps.com, (iii) your participation or inability to participate in the games and the Sweepstakes, and (iv) your other uses of TaoSweeps.com.

11. Publicity
